III. Finances:

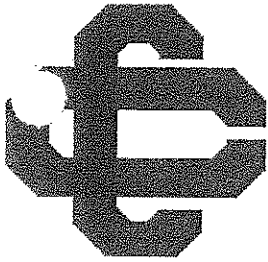
