The State Aid note, for \$1,000,000 was awarded to Chemical Bank this year. Repaid this years note to Thumb National Bank.

Goal setting for the 2015-2016 school year was discussed and it was determind that Mr. Hartel will email a list of potential goals to the board members and will address them at the September meeting.

Don Markel presented to the board the Jr/Sr high school preparation for the new school year including literacy training and CPR training as well as department meetings. He also reported on athletics and stated that the athletic season has already begun. All high school coaches are receiving the required CPR training. The cost for Greater Thumb Conference admission has risen to \$5.00 for high school events and will remain \$4.00 for jr

high school events. Cass City students will receive a pass at the start of school for free admission to home sporting events.

Aaron Fernald reported on the elementay school and stated that the teachers attended an inservice on August 17th for the new reading series that was purchased this summer. Class lists are posted and he feels they are ready for the opening of school and that the building itself is looking the best it has in a long time
