# CASS CITY PUBLIC SCHOOLS CASS CITY, MICHIGAN MINUTES OF THE BOARD OF EDUCATION December 16, 2013

The regular meeting of the Cass City Public School Board of Education was called to order on December 16, 2013 at 7:00 p.m., in the Cass City High School Library by President Craig Bellew.

The meeting agenda was reviewed. It was moved by Alice Zaleski, supported by Sloane Stimpfel, that the agenda be approved as presented. **All Ayes. MOTION CARRIED.** (A copy is in the Secretary's book.)

The Board heard an update on the buildings from David Barnes, Maintenance Director along with a report from Randy Schuette, Grounds Supervisor.

Superintendent Hartel informed the Board, that a new start/end time for the Jr./Sr. High School will begin on January 06, 2014. The new clock hours will be from 8:05 a.m. – 2:58 p.m., supersedeing the previous school day schedule of 8:10 a.m. through 3:03 p.m.

#### **Unfinished Business:**

The Board discussed options for the Campbell (Elementary) Building. It was moved by Sloane Stimpfel, supported by Alice Zaleski, that the building be listed for sale (reserving the right of refusal) with the Board voting on any fair market bids received. The motion was then withdrawn. The issue will be revisited at the January 27, 2014 board meeting, after Superintendent Hartel has had time to talk with village officials, regarding zoning options for the building and also listing the property with Osentoski Realty Co. and Kelly and Co. Realty, both of Cass City, MI.

<u>Student A -</u> To be suspended for the remainder of the first semester, with the following stipulations:

- 1. Student is not allowed at any school functions during this time.
- 2. Student must contact Principal Daniels on Monday, Wednesday and Friday for update on his homework.
- 3. Student must report after school (when needed) for homework support and to take tests/exams.
- 4. Student will return to school on January 20, 2014 (second semester) under the one (1) point rule. If there are any more discipline issues, student will receive an automatic suspension.
- <u>Student B</u> (12<sup>th</sup> grader) a policy exception is to be made and the student may to return to CCPS under the School of Choice Program (starting second semester – 01/20/14) for the remainder of the school year.
