The annual State Aide Resolution for borrowing funds to meet the district's summer cash flow needs were discussed. It was moved by Janie Meeker, supported by Stacey Bliss, that the resolution in the amount of \$1,000,000, be approved until state funding payments resume in the fall. **All Ayes. A motion was made by Janie Meeker, supported by Stacey Bliss to approve a 1% raise for all Administrators, Salaried Support Staff, Secretaries, Daycare Director, Para pros, Bus Drivers and Mechanic. All Ayes. MOTION CARRIED.

The results of the Integrated Designs, Inc. Faculty and Staff Surveys were presented. The results were as expected and in line with the needs that we were anticipating. (Copies are in the Secretary's book)

Superintendent Hartel presented the Top 10 in Ten, that is Michigan's plan to fulfill the requirements of the Federal ESSA (Every Student Succeeds Act). (A copy is in the Secretary's book)

Elementary Principal Fernald talked about the 3<sup>rd</sup> grade reading timeline. This year's Kindergarten students must be proficient in reading by the 3<sup>rd</sup> grade based on the approved tests. An update on the status of the GSRP/Preschool programs was given. This fall there are plans, as of right now, to only have 1 section of GSRP. This is due to not being able to accept over income students. We are hoping to capture the non-qualifying students with a tuition based school run preschool. This will be modeled after the GSRP program.
