Reports and Communications:

Christine Young from the Economic Development Corporation gave a presentation on the EDC millage that will be held on February 24, 2015.

Student winter count at this time is, that the Elementary is down eleven (11) and the Jr/Sr High is down twelve (12). We have lost 23 students from fall. Total student count currently is 1,032.

The Board heard the 2014/2015 Budget Amendments (general & title fund) from CFO, Mary Cunningham. It was moved by Daniel Manwell, supported by Janie Meeker that

Superintendent Hartel collected estimates on the bus garage roof, parking lots, ceiling panels at Jr/Sr High School, and technology updates, as requested by the board. Prioritizing and decisions need to be made on which to work on. Mr. Hartel also reported that Reese Public Schools would like to purchase one of our sub busses paying \$4,000. (A copy is in the Secretary's book)

Mr. Hartel also reported on the Bridge Magazine rankings. The Jr/Sr High School ranked 49 out of 630. The Elementary School was not ranked because of the 5th and 6th grade not being counted as elementary for 3 years.
