The entry age for kindergarten will be gradually changed to require children to be 5 years old by September 1st rather than the current cutoff date of December 1st.

# 2013-14 School Year

A child who resides in a public school district or public school academy providing kindergarten may enroll if the child is at least 5 years of age on NOVEMBER 1, 2013.

# 2014-15 School Year

A child who resides in a public school district or public school academy providing kindergarten may enroll if the child is at least 5 years of age on OCTOBER 1, 2014.

## **2015-16 School Year**

A child who resides in a public school district or public school academy providing kindergarten may enroll if the child is at least 5 years of age on SEPTEMBER 1, 2015.

### CASS CITY ELEMENTARY 4805 ALE STREET CASS CITY, MI 48726 Kindergarten Waiver Request for 2013-2014 School Year

According to Michigan Law, if a child residing in Cass City Public Schools District is not five years of age on November 1, 2013 but will be five years of age not later than December 1, 2013, the parent or legal guardian of that child may enroll the child in kindergarten for the 2013-2014 school year if the parent or legal guardian notifies the school district in writing not later than June 1, 2013, that he or she intends to enroll the child in kindergarten. If a child becomes a resident of the Cass City Public Schools District after June 1, the child's parent or legal guardian may enroll the child in kindergarten for that school year if the parent or legal guardian submits this written notification not later than August 1, 2013 under this subsection.

A school district that receives this written notification may make a recommendation to the parent or legal guardian as to whether the child is not ready to enroll in kindergarten due to the child's age or other factors. Regardless of the district recommendation, the parent or legal guardian retains the sole discretion to determine whether or not to enroll the child in kindergarten if the student is five years of age not later than December 1, 2013.
