A hard copy of this report will also be available for review in the superintendent's office. Each school will also be communicating their own AER to parents as well. These reports contain the following information:

- 1. Student Assessment Data Elementary or middle school assessment results on the Michigan Student Test of Educational Progress (M-STEP), high school assessment results on the M-STEP component of the Michigan Merit Exam (MME) and assessment results for students with disabilities on Michigan's Alternative Assessment Program (MI-Access).
- 2. **Accountability Scorecard** Detailed data and status update.
- 3. Teacher Qualification Data -
 - Identifies teacher qualifications at the district and building levels
 - Reports percentage of core academic classes taught by teachers not considered highly qualified to teach such classes.
- 4. National Assessment of Educational Progress (NAEP) -
 - Provides state results of the national assessment in mathematics and reading every other year in grades 4 and 8.

- 4. Accountability of our teaching staff using the Charlotte Danielson Framework for Teaching Assessment and for administrative staff; the MASA School Advance Model.
- 5. Providing after-school homework support with a certified teacher.
- 6. Dean of Students meets with all junior students and parents to discuss post secondary plans.
- 7. Review MiSSG website to ensure all TIP students are enrolled and FAFSA's have been completed.
